Tustin Pickleball Board of Directors Minutes of the Meeting June 22, 2020

A meeting of the Board of Directors of Tustin Pickleball, a State & Federal non-profit corporation, was held at the home of Albert Tjan, in Irvine, California, on June 22, 2020.

- **1. CALL TO ORDER** President Phil Dunmeyer opened the meeting at 4:12 pm.
- **2. PREVIOUS MINUTES** Minutes of the March 2, 2020 meeting were reviewed and approved via email.

3. Re-Opening of Tustin PB – (Phil Dunmeyer)

- (a). Target date to re-open courts is June 29th (pending approval by the district)
- (b.) Facilities use request July 1 December 31 pending district approval of guidelines.
- (c). Insurance Coverage Coverage with Tulip Insurance for July-December is pending.

4. Re-Opening "Road Bump" – (Phil Dunmeyer)

- (a). District Charge for Daily Bathroom Usage The issue has been resolved and we will only be charged for Saturdays. The bathrooms are open Monday Saturday.
- (b). Results of District Meeting on June 17th on this issue.

5. Re-Opening Structure – (Phil Dunmeyer)

- (a). Number of Days to Open Phil D. made a motion to have the courts open Monday Saturday. Seconded by Wayne and voted unanimously.
- (b). Open Hours Peggy made a motion to have courts open 7 till noon. Wayne seconded and the motion carried unanimously.
- (c). Court Accessibility Gates will be opened at 6:30 am for set-up. District will lock gates at the end of the day. We will leave "inner" court gates open to reduce contact.
- (d). Equipment Provision No equipment will be provided. Players must bring their own balls and paddles.
- (e). Lost & Found Players are responsible for their own possessions. Board members will not be picking up any items left behind.

6. Covid-19 Requirements – (See Covid-19 Guidelines & Practices) (Phil Dunmeyer)

- (a). Trial Period (Members Only) A motion was made by Albert to have a trial period for members only of 3 months later revised to two months to reduce the numbers of players on the courts. Motion was seconded by Craig and carried by majority with Phil D.. dissenting
- (b). Masks Masks not required while playing, however, will be while waiting for courts.
- (c). Social Distancing A separation of 6' must be maintained while waiting for courts.
- (d). Gloves Gloves are optional and not required while playing.
- (e). Balls Players will try to avoid touching the balls where possible.

- (f). No Physical Contact Players must maintain social distancing with no handshakes, fist bumps, etc.
- (g). Illness No player should come to the courts if they are not feeling well.
- (h). Players should bring their own hand sanitizer. Tustin PB will try to provide if necessary.
- (i). Roster of Participants All players will be required to check in at the front gate and provide their Membership Information (Name, Address, Phone and Email)

7. Crowd Control – (Phil Dunmeyer)

- (a). Doubles Play Only
- (b). Seating Players must bring their own chairs. Benches are off limits and will be covered.
- (c). Wait times Players waiting on a court must allow for 6' Social Distancing. If more than 4 are waiting for a court, then they must wait their turn outside the chain link fencing.
- **8. Tustin Pickleball Alternatives** (Phil Dunmeyer) Discussion tabled for now.

9. Labor Day Tournament – (Craig Haas)

- (a). Discussion on whether to schedule a Labor Day Tournament September 5-7.
- (b). Jay would be Tournament Director following Tustin PB Guidelines.
- (c). Ellen B. motioned to have the tournament and May H. seconded. Unanimous reply.

10. Miscellaneous – (Phil Dunmeyer)

- (a). Tustin BOD Apparel Discussion of hats to identify BOD members on the courts.
- (b). VETS Albert said that the group home has expanded (70 people) and that they look forward to our coming out and playing pickleball with them.
- (c). Facebook Posts May
- (d). Screening Peggy showed a material that she would like to install to alleviate the leaf problem on Courts 1-3.
- (e). Website Maintenance Craig plans to look into a new website that allows more flexibility when creating spreadsheets and entering new information on members.
- (f). Ben Johns and Simonie Jardin will host three clinics on the Tustin courts. The clinics are Scheduled for August 10th, from 8:00 am to 12 noon, and 1:00 to 5 pm. The third clinic is For August 11th from 1:00 pm to 5 pm.
- (g). Round Robin At our March 2nd BOD meeting we voted to host a round robin event on Sunday, August 23rd. The BOD agrees to move forward with this tournament.
- (h). Next BOD Meeting Scheduled for July 13th at 4pm.
